## 2020 HP Rifle Program - NRA Sanctioned League Matches

**NRA Sanctioned League Matches:** Competitors scores and NRA registration fees are sent to NRA competitions at year's end and count toward your NRA HP classification.

**Dates:** Sat-May 9<sup>th</sup>, Sat-June 6<sup>th</sup>, Sat-June 13<sup>th</sup>, Sat-July 11<sup>th</sup>, Sat-Aug 15<sup>th</sup>

**Location:** SSA club grounds. 5426 Footville-Richmond Rd. Richmond Township, OH 44003

**Directions:** I-90 to SR11 exit 228.  
SR11 South to SR 307. East on 307 to SR193.  
North on SR193 to Footville Richmond Rd.  
East on Footville Richmond Rd. to Club  
Property approximately 4 mi. on the right.

**Time to arrive:** Front gate will be open from 7:00 AM until 8:00 AM for sign in and squadding.

**Squadding:** Sign in and squadding is at the building just inside the gate between 7:00 and 8:00 AM with final adjustments made on the range. Match will begin at approximately 8:30 AM. Four relays are planned. All competitors must present themselves when their relay is called, and report for his duty in the pits before they seal to be scored in this event.

**Time of Firing:** Pits will seal at 8:20 AM Firing will begin thereafter from the 200 yard line.

**Range capacity:** This match is limited to 40 shooters.

**Entries at the match:** Until 8:00 AM

**Entries by mail:** None

**Rules:** SSA & NRA Competition rules will apply.

**Eligibility:** SSA & Non SSA members are welcome. All match entrants should be fully completely familiar with NMC procedures. Competitors must sign a an annual liability release agreement. All rifles shall have a known 200 yard zero, minimum.

**Fees:** \$20 per Adult. Solon Members are \$5.  
Juniors (NRA rule 2.3) are \$5

**Rifles Allowed:** Service, Any or Match. NRA Rules 3.1, 3.2, & 3.3. There will be two divisions NRA Match Rifle and Service, unless there are less than 5 rifles in a class, if so, they may be combined.

**Ammunition:** Competitors must supply their own ammunition. No incendiary or tracer ammo is permitted.

**Sights:** Metallic or Optic Sights per NRA rules

**Sighters:** Two sighting shots are allowed prior to each match. Sighting shots may be taken in a position other than that specified for the stage, but such position must be one of those described in Rule 5 of the High Power Rifle Book, except 5.13.

**Course of Fire:** NRA 7.15 80 Shot Regional Course

**Match 1** Standing Slow Fire  
20 shots for record slow fire,  
20 minutes @ 200 yards

**Match 2** Sitting/kneeling Rapid Fire  
20 shots for record in 2-10 round strings,  
60 seconds each, rapid fire @ 200 yards.

**Match 3** Prone Rapid Fire  
20 shots for record in 2-10 round strings,  
70 seconds each, rapid fire @ 300 yards.

**Match 4** Prone Slow Fire  
20 shots for record  
20 minutes @ 600 yards

**Match 5** The match winner is the highest score in the aggregate of stages 1-4
